A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY
OF LYONS TO SET THE CITY OF LYONS 2019 MILLAGE RATE

Discussion:

WHEREAS, The City of Lyons is required by O.C.G.A. sec. 48-5-32.1 to adopt a millage rate after satisfying the advertising and public hearing requirements; and

WHEREAS, the City of Lyons has met the advertisement and public hearing requirements set forth in O.C.G.A. Sec. 48-5-32.1; and

WHEREAS, The Mayor and Council of the City of Lyons wish to adopt a Resolution levying a millage rate, which is established for purposes of financing, in whole or in part, the City's expenses for the fiscal year 2019; and

WHEREAS, The Mayor and Council of the City of Lyons have studied and reviewed the City's existing millage rate of 2.89 mills and have concluded that it not sufficient to fund the City's expenses for the fiscal year 2019; and

WHEREAS, The Mayor and Council of the City of Lyons have determined that a millage rate of 3.89 mills is needed to fund the City's expenses for the fiscal year 2019.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of Lyons, Georgia, that the 2019 millage rate is set at 3.89 mills for tax year 2019.

CITY OF LYONS MILLAGE RATE PUBLIC HEARINGS SCHEDULED

The City of Lyons has tentatively adopted a millage rate of 3.89, which will require an increase in property taxes by 29.54 percent. The proposed millage rate is 1 mill more than the prior year millage rate of 2.89 mills.

All concerned citizens are invited to the public hearing on this tax increase to be held at the Lyons City Hall located at 161 N.E. Broad Street Lyons GA 30436 on September 12, 2019, at noon; September 12th at 6 pm and September 19th, 2019 at 6 pm. 

This tentative increase will result in a millage rate of 3.89 mills, an increase of 29.54 percent. The proposed tax increase for a home with a fair market value of \$100,000 is approximately \$40.40.
